MEMBERSHIP INFORMATION

In accordance with Article VI of the By-Laws that govern the National Pony Express Association (NPEA) the Colorado Division establishes these instructions for official riders of the NPEA:

Riders MUST abide by the Pony Express Oath.

HORSE & WESTERN TACK INSTRUCTIONS

- A. Horse/Equine must be in reasonable condition for the ride or event.
- B. Horse/Equine must be trimmed or shod suitable for the ride terrain.
- C. Tack must be in good and safe condition.

RIDER

- A. Riders must be able to mount and dismount their horse/equine.
- B. Must be at required location prior to starting time of ride and complete ride in allotted time.
- C. Must be familiar with the ride terrain and course.
- D. Must wear appropriate western attire (see uniform requirements below) and/or safety gear.

ELIGIBILITY REQUIREMENTS

NOTE: Colorado rides are normally in dusk to dark conditions. Rider and mount must be capable and ready for a night-time ride.

- A. Riders must be at least 14 years of age and have prior parental/guardian written consent to ride.
- B. Only Members may ride and MUST have signed insurance liability forms prior to the ride commencing.
- C. Riders may ride in pairs/shadow riders are acceptable.
- D. Riders MUST take the Pony Express Oath prior to the Re-Ride each year.
- E. For safety purposes, horses and equipment may be inspected by ride officials and can be disqualified if found unsafe or unsound.

DRESS CODE INSTRUCTIONS:

- 1. RE-RIDE
 - Blue jeans, long sleeved red western shirt, yellow necktie/wild rag/scarf, brown vest, brown western hat, brown boots.
 - (Colorado minimum requirements are: blue jeans, long sleeved red western shirt, yellow necktie/wild rag/scarf, western hat and western riding boots.)
 - XP patches and gear are encouraged.
- 2. PARADES and other special events
 - Re-Ride uniform minimum.
 - Some riders have additional XP gear like XP chaps/chinks and saddle blankets/pads.
 - Some members have vests and some do not. Riders will match as much as possible for parades and be in the minimum uniform requirements. Ride captains/event coordinators may ask riders to take extra uniform items off for the event.
 - XP patches and gear are encouraged.
