I also understand that all equines, even if they have no history of hurting anyone, are powerful and have the potential to be dangerous to people, equines, and other animals.

I also understand that riding, driving, handling, working with, or even being near an equine can expose me to numerous hazards, which could include, for example: the propensity of an equine to behave in ways that may result in injury, harm, or death to persons on or around them; the unpredictability of an equine's reaction to sounds, sudden movements, and unfamiliar objects, persons, or other animals; certain hazards such as surface or subsurface conditions on the land where The Activities take place; and/or collisions with other equines, animals, or objects. I understand these risks and dangers that are inherent in equine-related activities, and I agree to assume all of these risks. I understand that these are just some of the risks, and I agree to assume others that are known and unknown and not described here. I am NOT relying on Association to list all possible equine-related risks in this document, now or in the future.
