**INSTRUCTIONS TO RIDERS**

In accordance with Article VI of the By-Laws governing the National Pony Express Association, we do hereby establish these instructions concerning official riders of the National Pony Express Association:

- I. **Rider must abide by the Pony Express Oath.**
- II. **Horse & Tack Instructions**
  - Hooves must be trimmed or shod suitably for the terrain.      •Horses must be in reasonable condition for assigned ride.
  - Tack must be in safe condition.
- III. **Rider Instructions**
  - Rider must be able to mount and dismount horse.      •Rider must be at designated location 30 minutes prior to starting time of assigned ride and complete ride in approx. 12 minutes.      •Rider must be familiar with his/her designated ride.
- IV. **Dress Code Instructions (Riders must wear appropriate attire)**
  1. **Re-ride** Blue jeans, long sleeved red shirt, yellow necktie, brown XP vest with XP logo, brown western hat, brown boots, and brown XP saddle blanket cover.
  2. **Parades and other Special Events (Unless otherwise designated)** Dark blue pants, long sleeved red shirt, yellow neck tie, brown XP vest with XP logo, brown western hat, brown boots and brown saddle blanket cover with XP logo.
